COVID-19 and supply issues	Ongoing	PHARMAC has contacted all contracted medicine and device suppliers to seek information about any potential impacts to supply and their contingency plans. The majority have responded to confirm that they have contingency plans in place and are actively managing their supply chains as best they can. Some suppliers have advised us that they anticipate future disruptions due to supply, whether due to manufacturing or transportation. We are working closely with them to determine the best approach to manage potential shortages. There are supply issues with paracetamol and PHARMAC placed temporary dispensing limits on Government-funded paracetamol from Monday 9 March 2020.

Hon Michael Woodhouse to the Minister of Health (11 Mar 2020): What monitoring, if any, of medicine stockpiles is being done and how regularly is this being done, if at all?	Pharmaceutical suppliers under PHARMAC contracts are required to keep a minimum stock in New Zealand equal to two months' demand. There is typically another four to six weeks' worth of stock across the wholesale and retail supply chain. Some medicines (for example some oral antibiotics) have a greater minimum stock holding requirement, such as four months. PHARMAC manages its relationship with contracted suppliers to ensure they are meeting their minimum stock holding obligations and to enable management of any emerging supply issues.

		Other than some funded vaccines, PHARMAC itself does not purchase or hold stocks of any medicine. Monitoring of medicine stocks, once purchased by community pharmacies and DHBs, is generally the responsibility of those individual entities. However, the Ministry of Health's National Health Coordination Centre has recently been engaging with DHBs to determine national stock levels of essential medicines held by DHBs.

Alastair Scott to the Minister of Health (16 Mar 2020): How many, if any, AFLURIA QUAD and AFLURIA QUAD JUNIOR vaccines have been secured for the New Zealand population for the 2020 influenza	PHARMAC reports that the supplier of Afluria has committed to supply 1.44 million doses of Afluria Quad and 20,000 doses of Afluria Quad Junior to New Zealand for the 2020 influenza season. These vaccines will be distributed for publicly funded vaccinations of eligible patients, and will also be available for privately funded vaccinations.
	season?	PHARMAC advises that an additional 300,000 influenza vaccines have been sourced from an alternative supplier, which means the total number of influenza vaccines available for the New Zealand market is 1.76 million doses.
