# Government response to independent Pharmac Review

The Government has released its response to the recommendations of the final report of the independent Pharmac Review panel, welcoming its insights as well as Pharmac's commitment to improve in its role for better health equity and outcomes for all New Zealanders.

"We made <u>an election promise</u> to conduct an independent review to look at how well Pharmac performs against its objectives, and whether those objectives need changing," Health Minister Andrew Little said.

"Securing the health of New Zealanders is a key priority for our Government. Ensuring Pharmac is working well as part of the total health system has been part of our plan.

"In Budget 22 we made the largest single contribution to Pharmac's Medicines budget ever bringing total funding to \$1.2 billion. This has already seen Pharmac launch consultations on proposals to fund medicines for conditions including cancer and multiple sclerosis.

"Our drug-buying system was set up nearly three decades ago and with the new health system ready to get to work come July 1, we knew it would be sensible to look at how well Pharmac is doing and ensure it is aligned with the principles of our health system rebuild.

"Pharmac's purpose is to secure the best health outcomes that are reasonably achievable from pharmaceutical treatment from within the amount of funding provided.

"The panel found Pharmac's model has delivered significant benefits, but to achieve its purpose these benefits need to be shared more equitably across our communities, especially for Māori and Pacific peoples," Andrew Little said.

"As a result of this Review, Pharmac will have a much greater focus on improving the health of Māori, Pacific peoples, disabled people and other groups who do not yet share equitably in the benefits Pharmac provides.

"This will mean stronger relationships with Māori to honour te tiriti o Waitangi, that Pharmac is more inclusive of people with health needs, and explains its work more openly for the public.

"The Pae Ora Bill will put into action many aspects of the recommendations made by the Review Panel to be more collaborative, engaging and equity focused.

"Pharmac has confirmed to me that it accepts the Panel's findings. Pharmac is committed to making the needed strategic and operational changes, and already has work underway to do this.

"The panel made 33 recommendations and the government agrees in principle with most of them. There is a small number of recommendations where the government takes a different view, for example where the health reforms will address the underlying issues now or in the future," Andrew Little said.

"The main change is that Pharmac will be required to engage more with health consumer voices and to more actively collaborate and co-ordinate with other parts of the health administration.

"For example, developing a vaccine strategy is not just a matter of good procurement but needs to take account of a broader range of objectives which the Ministry of Health must be integrally involved with."

- Out of scope matters included Pharmac's role making pharmaceutical decision on behalf of the government, funding, commercial-in-confidence and day-to-day operations.
- The review panel's <u>interim report</u> released in December 2021 highlighted the need for greater attention to improving equity and greater transparency.

Pharmac has already gotten to work on implementing the changes, and many of the recommendations will be enabled by the Pae Ora (Healthy Futures) Bill which is currently before Parliament. There is much to be done across the health sector to secure New Zealanders' health for the long-term, and by Pharmac in making the needed improvements.

While the full changes will take time, I am confident that improvements will start to be seen. All New Zealanders can be assured that Pharmac will be working for them, their whānau and communities.

# **COVID-19 Vaccine Purchasing and Management Transfer**

#### Portfolio Health

On 18 May 2022, the Cabinet Social Wellbeing Committee:

- noted that in December 2021, the Cabinet Social Wellbeing Committee:
  - agreed in principle, subject to paragraph 1.3 below, to transfer responsibility for the ongoing management and purchase of COVID-19 vaccines from the Ministry of Health to Pharmac from 1 July 2022;
  - 1.2 noted that COVID-19 vaccines will continue to be funded separately from the Combined Pharmaceutical Budget and Ministers will continue to approve final decisions on purchases;
  - invited the Minister of Health to report back to SWC in May 2022 setting out the arrangements for the decision in paragraph 1.1 above;
  - directed the Ministry of Health and Pharmac to work closely together before and after 1 July 2022 to ensure the transition occurs smoothly;

- 2 **noted** that the Ministry of Health and Pharmac have considered the existing COVID-19 Vaccine and Immunisation Programme structure to understand how successes in the programme were achieved, including:
  - 2.1 an integrated single programme;
  - 2.2 funded to achieve its objectives;
  - 2.3 with strong leadership and accountability; and
  - a clear line of sight for Ministers;
- agreed that Pharmac, the Ministry of Health, and the Public Health Agency will collectively work together as part of the National Immunisation Programme on:
  - 3.1 identifying and agreeing on need, including establishing the best purchasing approach to support the strategy and outcomes for the National Immunisation Programme; and

- 3.2 horizon scanning and identifying and agreeing on purchase options that will best support the purchasing approach;
- 4 **agreed** that Pharmac will take over responsibility for the COVID-19 vaccine purchasing and management process:
  - 4.1 advising on purchasing and management decisions that support the outcomes of the immunisation programme, and are responsive to emerging needs and changing priorities;
  - 4.2 relationship management with suppliers to support programme outcomes and mitigate risks; and
  - 4.3 advising on utilisation and/or maintaining access to COVID-19 vaccines (in collaboration with the Ministry of Health, Ministry of Foreign Affairs and Trade, and new health agencies), and is aligned with the overall approach to purchasing and management (for example maintaining access to vaccines but not taking receipt and donation);
- agreed that that COVID-19 vaccines will continue to be funded separately from the Combined Pharmaceutical Budget, and final purchasing decisions on COVID-19 vaccines will be approved by Vaccine Ministers;
- agreed that Pharmac will also be responsible for the existing COVID-19 purchasing and management functions, including:
  - 6.1 contract management of the existing Advance Purchase Agreements and any necessary future contracts, including any business case for indemnities to support Treasury advice to the Minister of Finance;
  - 6.2 supplier relationship management and issue resolution;
  - 6.3 legal support;
  - 6.4 financial management; and
  - 6.5 programme inventory, including supply and demand and delivery management (excluding internal logistics within New Zealand and distribution to vaccinators, which is currently managed by the immunisation programme);
- agreed that any future changes to COVID-19 vaccine purchasing and management process required to support the strategy and outcomes for the National Immunisation Programme will be managed by Pharmac;
- agreed that Pharmac will be responsible for ensuring COVID-19 vaccine purchasing and management aligns with:
  - 8.1 the COVID-19 Vaccine Strategy and COVID-19 immunisation programme;
  - 8.2 the strategic intent, priorities, and desired outcomes for the National Immunisation Programme;
- agreed that the Ministry of Health maintains responsibility for establishing system strategy and policy settings for the immunisation programme with system leaders;

- **noted** that to support Pharmac with the purchasing and management of COVID-19 vaccines:
  - a pathway or end-to-end view from development of strategy and outcomes, policy and programme response and alignment of objectives and outcomes across programmes needs to be:
    - 10.1.1 maintained for the COVID-19 Immunisation Programme;
    - 10.1.2 established for the National Immunisation Programme;
  - the COVID-19 immunisation programme, alongside Pharmac, will collectively achieve outcomes by establishing the necessary oversight and accountability functions;
- noted that there is broad agreement that strategic direction, governance, and oversight are needed to steer and coordinate all system activities contributing to immunisation outcomes;
- noted that the Ministry of Health will be responsible for establishing the necessary governance mechanisms and settings to collectively achieve outcomes, and will report to Ministers by August 2022;
- noted that there is likely to be additional funding required to support Pharmac and this will be considered by Ministers alongside any future purchasing needs.

# Kia ora koutou,

I wanted to touch base about the Pharmac review and today's public release of the final report and the Government's response. I know there is high interest in the review and its outcomes. You can read it on the <a href="Pharmac Review website">Pharmac Review website</a>.

There is a lot to digest, and we look forward to discussions with you and a wide range of parties ahead, about both the review findings and government response.

The Panel has found that Pharmac performs an important role and New Zealanders benefit from its work. Throughout the recommendations are the themes of equitable health outcomes for Māori and other populations, transparency, collaboration, and consumer input. We agree that these are all important matters that need continued high focus ahead, and changes that enable us to be more effective.

We see the review as an opportunity for us to wananga, to improve and grow as an organisation. We take a lot of confidence from the Government's response – they acknowledge the important role we play and our ability to perform. What we do isn't changing, but how we do it does need to change. And we need to work with our health system partners on what that change looks like.

We are required to report back to the Minister of Health on Pharmac's response to the review – an initial plan is due by the end of July and a more detailed plan in October. What we are doing now is identifying what new, additional and expanded pieces of work will be needed to respond to the review recommendations.

We see great opportunity for improvements to how we operate and look forward to working more closely with our health sector colleagues and other stakeholders in developing and implementing changes to how we do our work.

I look forward to the journey ahead, working together to further enhance Pharmac's effectiveness and the confidence others have in our work.

I only had a few minor comments to add (mostly suggestions bouncing off Ben's comments), but the document is locked for editing.

The main thing I would suggest is softening the language of this para:

"In briefing the Pharmac Board on the review recommendations, the review chair Sue Chetwin focussed exclusively on one example of a disagreement between Pharmac and MoH that the review committee was briefed on by MoH staff, as if to suggest that this was the key grounds for vaccines responsibility to transfer from Pharmac."

Particularly suggest removing Sue's name, and reworking "as if to suggest" – both come across emotive and overly personal. Is this specific example also reflected in how the case is made in the review report? Fair call out to make if it is also in the review report, but if not, focusing on how this was presented to the board in a presentation doesn't seem like the strongest argument for us to make.

Kia ora Sarah

We received an updated version of the report yesterday (attached).

The revised report reflects further editing and factual corrections provided by Pharmac after it reviewed the previous version. There has also been some changes in formatting to make the graphs easier to read and reduce the number of appendices, but the content remains largely unchanged.

There are two items in the report that are not yet in the public domain:

This table includes the 33 formal recommendations made in the review, but also captures other suggested actions that are made throughout the document.


Broadly, the response that Pharmac takes for each rec is going to be one of either:

- Support i.e. we could readily incorporate the recommendation into current workplans without significant impact on resources (although may require some re-prioritisation of other work).
- Support in principle however may require scoping to determine additional resource requirements, feasible timeframes etc. Many of these responses are likely to require operational uplift to support.
- Hold concerns about i.e. recommendations we have some reservations about.

Once SLT have provided input into the table (i.e. through discussion on Friday morning), I will work on the briefing to the Minister. What this briefing ultimately looks like will largely depend on whatever signals the Minister provides in his meeting with Sarah on Monday.





#### Hi Allanah

Here's the input we gave for the Cabinet paper for the interim report (drafted by Rachel I think) and the longer internal summary doc (drafted by Peter and Michael I think).

While neither is an actual briefing, I think these are useful as they are in a style and tone that we know SLT and Sarah are comfortable with and should give you a good feel for how they like to talk about things.

Sarah noted to me yesterday that 'we need to be very careful not to come across as too defensive'

My feeling, as I work through the monster of a table (truly, it is SO LONG), is that there will be three broad categories:

- 1. Recommendations we support and could readily incorporate into current workplans without significant impact on resources (although may require some re-prioritisation of other work)
- 2. Recommendations we support in principle but require scoping to determine additional resource requirements, feasible timeframes etc etc. Many of these are likely to require operational uplift to support. There are a fair few in this category
- 3. Recommendations we have some reservations about my feeling is that there are likely to be very few of these but if we choose to contest the vaccine rec that is a pretty major one

I am not sure if we want to also include a flavour of "there were some things we expected to see but didn't" – but I will be including some of those in the table, for completeness.

The Minister was open to hearing concerns. He raised Vaccines and Devices unprompted "wouldn't that cause commercial problems?" Yes!

Vaccines – we can do more to work more closely with MoH and the rec doesn't fit with the move of covid vaccines.

Devices – FPIN project not mentioned in report. Moving the staff from one org to the other doesn't make sense.

Rump up the positivity, step back and emphasise equity: we are on a journey.

Board are meeting this Thursday. This meeting needs to happen before briefing goes to Minister. Strategy paper due for then.

In general: Emphasise resourcing requirements are pretty high for not much gain. Leave the "what is missing" part from the Min's briefing. Better to have this discussion with the Board (and plenty of other people will say this – we don't need to).

Minister is keen to release quickly e.g. end of April. Conscious of budget announcement timing.

Paper needs to indicate work we have done.

Responsible use – we will never not do stuff in this space, e.g. adalimumab/brand switch work. Need to discuss with Board.

Medicines Strategy – we should reiterate the importance of this, as many streams of work line up and fall out of this.

Note Vaccine and Devices commercial activity and staffing risks.

#### SLT review feedback

K – particularly in the areas where we don't support recommendations the tone was defensive. In the collaboration legislation recommendation, we should support collaboration, but not the implementation mechanism.

MJ – Was being quite hard with the wording, as this is an internal document. We do not support legislation, but we support intent. When we go externally we will frame it differently.

Supply chain, e.g. we do not support recommendation, but intent is ok.

Sarah – want this document to be the basis for the briefing, so language needs to be reflecting what we would use externally.

Trevor – we need to emphasise what isn't said

Lisa – vaccines. Where does implementation go? If Heath NZ are commissioning implementation programmes, will it be funded properly?

Present the evidence of Pharmac's involvement.

Sarah – devices – the tone makes it sound like we are disengaged on the work. That is not for want of trying.

Lisa – the key logic of transferring devices in 2010 has been ignored. HNZ will have so many things to focus on, things like this will drop into non-priority for them.

Peter – these things came to us that a national model was needed, and Pharmac had the skills.

Lisa – seems weird for HNZ to now build up that capability

Peter – they would just take the function (and people).

Lisa - they should take it all... not just parts of it. Other parts of the report not that split functions don't work so wouldn't recommendation the same for this.

Devices – might lose negotiating power and staff if the recs aren't tightened to give a signal about when and how.

Same with vaccinations – we need to start the 2023 flu season... and taking covid vaccines in June.

Expected them to lead by example – no recommendations that give guidance about how we should be upholding to tiriti and equity, considering the experience of the panel.

## RELEASE OF THE GOVERNMENT'S RESPONSE TO THE INDEPENDENT REVIEW OF PHARMAC AND THE FINAL INDEPENDENT REVIEW REPORT

I will shortly today release the Government's Response to the Independent Review of Pharmac and the final independent review report.

Because of your engagement as a stakeholder I wanted you to receive both of these documents in advance of the public release. In fairness to everyone who has an interest in Pharmac's work I am asking that you respect an embargo which has been placed on the documents. This means the documents should not be shared before 11.00am, today, Wednesday 1 June 2022.

I am grateful for the efforts you and many others have made to provide important input to the Review.

The Government committed to an independent review to look at how well Pharmac performs against its objectives. Pharmac's purpose is to secure the best health outcomes that are reasonably achievable from pharmaceutical treatment from within the amount of funding provided.

The panel found Pharmac's model has delivered significant benefits, but to achieve its purpose these benefits need to be shared more equitably across our communities, especially for Māori and Pacific peoples.

The panel made 33 recommendations and the government agrees in principle with most of them. There is a small number of recommendations where the government takes a different view, for example where the health reforms will address the underlying issues now or in the future

Pharmac has accepted the Review's findings and is committed to making the significant changes needed. The main change is that Pharmac will be required to engage more with health consumer voices and to more actively collaborate and co-ordinate with other parts of the health administration.

Pharmac has already gotten to work on implementing the changes, and many of the recommendations will be enabled by the Pae Ora (Healthy Futures) Bill which is currently before Parliament. There is much to be done across the health sector to secure New Zealanders' health for the long-term, and by Pharmac in making the needed improvements.

While the full changes will take time, I am confident that improvements will start to be seen. All New Zealanders can be assured that Pharmac will be working for them, their whānau and communities.

#### Kia ora koutou,

I wanted to touch base about the Pharmac review and today's public release of the final report and the Government's response. I know there is high interest in the review and its outcomes. You can read it on the <a href="Pharmac Review website">Pharmac Review website</a>.

There is a lot to digest, and we look forward to discussions with you and a wide range of parties ahead, about both the review findings and government response.

The Panel has found that Pharmac performs an important role and New Zealanders benefit from its work. Throughout the recommendations are the themes of equitable health outcomes for Māori and other populations, transparency, collaboration, and consumer input. We agree that these are all important matters that need continued high focus ahead, and changes that enable us to be more effective.

We see the review as an opportunity for us to wananga, to improve and grow as an organisation. We take a lot of confidence from the Government's response – they acknowledge the important role we play and our ability to perform. What we do isn't changing, but how we do it does need to change. And we need to work with our health system partners on what that change looks like.

We are required to report back to the Minister of Health on Pharmac's response to the review – an initial plan is due by the end of July and a more detailed plan in October. What we are doing now is identifying what new, additional and expanded pieces of work will be needed to respond to the review recommendations.

We see great opportunity for improvements to how we operate and look forward to working more closely with our health sector colleagues and other stakeholders in developing and implementing changes to how we do our work.

I look forward to the journey ahead, working together to further enhance Pharmac's effectiveness and the confidence others have in our work.



I've been mulling on this matter, and think in order to present a good policy argument, we need to be thinking about what the case might be for moving vaccines - either away from Pharmac, or to another org (slight subtlety in difference of what the arguments might be depending on whether it is a case of "we don't think Pharmac should do it" versus "we think dept x should") and run those reasons through some policy thinking.

What are the risks? Mitigations?

If MoH are going to present the case that vaccines should move, the most common approach would be to sell the bells and whistles that could be achieved. When a specific solution is already on the table (i.e. moving vaccines), analysts often don't spend too much time thinking about the risks, leading to the overall advice downplaying this aspect. I suspect MoH might focus their energy thinking about the risks of vaccines staying with Pharmac and gloss over the risks of them moving anywhere else.

This is where we should do the leg work - being open to hearing about the risks they present, thinking about the mitigations we can offer, and then also presenting thoughtful risks back to them about the move.

I agree it is unfortunate MoH is not able to ask the Panel for its analysis - but there is no longer any panel, and Sarah Davies finished up today, so they are having to take the report at face value. Therese (and others from MoH) met with Sarah Davies yesterday and said she was helpful in explaining the rationale, which appeared to have shifted Therese's view more in favour of moving vaccines to PHA - the main points Therese raised with me this morning were our apparent inability to move quickly to respond to a public health issue such as need for a new strain of vaccine and that we don't fund things that public health thinks should be funded. The pneumococcal example came up AGAIN, although she framed it as a fictional example of 'what if ESR monitoring detected there was a need for a new meningococcal strain and public health wanted to move quickly to respond but Pharmac is too stuck in its processes to respond appropriately quickly"

I explained that -as per the summarised info for pneumococcal vaccine that I sent her on Tuesday (the same summary we sent the review) we have taken advice on the pneumococcal situation and our advice was that it doesn't need to be resolved with urgency - and we are working to resolve it. Her counter to that was to ask if the imms AC had the right expertise and to note that MoH wasn't involved in that advice. I of course explained that we have moh attendees at the meetings and assured her that the Imms AC has the right expertise. I also noted that we can and do respond quickly when there is a public health issue such as an outbreak or some other significant emerging issue - working with the MoH and seeking budget support if that's required.

The reason I am mentioning this is that any advice we give back will need to cover off our ability to move fast when needed as well as the collaborative stuff that others have provided great input and feedback to. The pneumococcal example has well and truly stuck firm.





52.3 for key vaccine decisions, agreement by three parties (the Ministry, the Public Health Agency and Pharmac) collectively on vaccines to be added to or removed from the Combined Pharmaceutical Schedule and their priority relative to other health priorities, bound by confidentiality rules in considering the information underpinning the decisions (noting that Pharmac would be responsible for making and effecting the final decisions through the Pharmaceutical Schedule);

54 The collective governance mechanism would support individual agency achievements, including Pharmac's, by strengthening accountabilities to the collective and highlighting impacts towards collective outcomes. Pharmac, like the other entities involved, would retain responsibility for its functions and decisions, and be accountable to the collective for responsiveness and support towards collective achievement of equity and health outcomes.

Para 52.3 and 54 contradict one another in my view

As discussed at the staff meeting today, the final report from the review of Pharmac is expected to be released tomorrow late morning.

I am sharing the executive summary of the review and the key points from the government response now, trusting that you will keep this confidential until the full public release of the review tomorrow. Tomorrow, the full report and associated documents will be posted onto Pātaka, along with the full Government's response to the review, an hour or so before its public release.

There is a lot of information to absorb. We recommend starting with the executive summary of the review report today, followed by the Government response and then the full review report and the supporting documents, if you choose to do so. You may choose to block out some time tomorrow to do that, you may take a few days to read through it all. Some of these documents are highly technical. There is no expectation on staff to read all of the review documents.

Have had another think about this. I'd suggest something more like:

- There are 33 formal recommendations to the Minister of Health in the report:
  - approximately half the recommendations relate to legislation/function changes and nationa strategies, mainly with the intent of ensuring that Pharmac focuses on its core business, improves cross-sector collaboration, and secures equitable outcomes for Māori and other populations. The Ministry of Health would be responsible for implementing some of these recommendations.
  - o the other recommendations relate more directly to how Pharmac undertakes its work

Some recs fall into both categories so it's not really possible to put an accurate number on them. If Lisa really wants that I'd suggest that she takes a look and makes a call on them – bearing in mind that the govt response to many of them may be different from the actual recs, which in several instances pushes them out of one category into another – I've tried to cover that off in the first bullet above. Otherwise there's a real risk that people will think the top half are not relevant to us which isn't the case.




