Proposal to list various radiological contrast media supplied by Regional Health Limited

PHARMAC is seeking feedback on a proposal, resulting from a provisional agreement with Regional Health Limited for the supply of various radiological contrast media products.

 - Varibar thin liquid
 - o Volumen
 - o X Opaque HD
 - o CT Plus+
- Listing the following radiological contrast media products in Part II of Section H of the Pharmaceutical Schedule:
 - o barium sulphate with sodium bicarbonate (EZ Gas II)
 - o gadobenic acid (Multihance)
 - diatrizoate sodium (loscan)
